WHEREAS, Receiver charitable entity, organized under the provisions of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended:

WHEREAS, Donor would like to make a charitable donation to Receiver, as under the laws of the United States and the applicable portions of the Internal Revenue Code of 1986, as amended;

NOW, therefore, in consideration of the promises and covenants contained herein, the receipt and sufficiency of which is hereby acknowledged, the Parties do hereby agree as follows:

Donor is pledging donations of vacant room nights to support fundraising for various charities. The donation will be auctioned a Charity Auctions only and will not be offered for sale in the secondary market.

Receiver will pay Donor One Hundred (\$100.00) Dollars per donation of each vacant room night with rack room nights of up to Eight Hundred (\$800.00) Dollars per night. Receiver will pay Donor an additional 12.5% for each Hundred Dollar (\$100.00) increase in rack room night over Eight Hundred (\$800.00) Dollars per night. The foregoing will be paid by Receiver to Donor within fourteen (14) days of auction. Payments will be submitted by wire transfer.

Entire Agreement: This Agreement constitutes the entire agreement between the Parties and supersedes any prior or contemporaneous understandings,

Counterparts: This Agreement may be executed in counterparts, all of which shall constitute a single agreement.
